1. That in pursuance of the premises above the Author of the Trust as settlor do hereby convey unto and settle upon the trustee the cash to hold the same upon Trust and the Trustees do each of them do hereby admit and acknowledge the transfer to them with powers and subject to the uses mentioned hereinafter.

2. That the name of the trust shall be "Om Sri Sai Sarnam" with its registered office situated at RPO : Amroh, Teh & Dist : Hamirpur (H.P) - 177020

3. That the Trust has been established with the object of (i) To work for the welfare of Poor & Needy, Youth & Children (ii) To organise function towards nation Integration (iii) To organise courses of studies for Welfare activities. (iv) To receive grants / Donations

4. That the Trustee shall stand possessed of cash hereby conveyed and settle upon and shall use and apply the interest, the profit and other income derived thereby for the purpose and object of the Trust as aforesaid.
